The regular monthly meeting of the Haverhill Town Council was held on Thursday, April 27, 2017 at the Town Hall, 4585 Charlotte Street, Haverhill, Florida. Those present were Lawrence Gordon, Vice Mayor; Mark C. Uptegraph, Council Member; Jo H. Plyler, Council Member and Remar M. Harvin, Council Member. Also present were Lance Fuchs, Town Attorney and Janice C. Rutan, Town Administrator.

CALL TO ORDER

Vice Mayor Gordon called the meeting to order at 7:00 p.m.

INVOCATION AND PLEDGE OF ALLEGIANCE

Vice Mayor Gordon offered the Invocation and led in the Pledge of Allegiance.

ROLL CALL

The Town Administrator called the roll. All members were present with the exception of Mayor Foy. (Councilman Harvin arrived at 7:20 p.m.).

COMMENTS FROM THE PUBLIC

Father Willie Davila from St. Christopher's Episcopal Church was present to address the Town Council. He introduced Attorney George Lewis and member John Evans to the Town Council. The reason for their visit was to receive an update on the Town's consideration of an ordinance that would regulate columbarium within the Town.

Attorney Fuchs responded that they had been looking into sample Ordinances from other municipalities and would most likely have a draft for consideration at the May 11, 2017 meeting. They would be in contact with Attorney Lewis for his input.

REGULAR AGENDA AND FIRST READINGS

Consider request for subdivision re: 5220 Club Road/Bethany Lane as filed for by Benito Chiara, property owner

Brian Chegus of I Plan and Design was present representing the applicant. He introduced Benito and Mario Chiara, applicants to the Town Council. The Chiaro's had purchased the property a year ago. The lot was a flag shaped lot and if approved, the subdivision would create two lots with access to the second lot being off of Bethany Lane, a private road.

The Chiara's were willing to enter into a Declaration of Ingress/Egress and a Maintenance Agreement regarding the private road with the current owner of the road, Duane Murrell. In addition, the Chiara's would provide a 12-foot roadway reservation to expand the present road to its minimum required 32 foot profile.

The Town Administrator reported that Town Attorney Foster, Town Planner Josh Nichols, Town Engineer Todd McLeod and Town Surveyor Craig Wallace reviewed the proposal and commented accordingly. The applicants' responses to those comments have been received and are under review.

Based on Staff's recommendation, a motion was made by Council Member Harvin, seconded by Council Member Plyler and unanimously passed (4-0) to approve the Chiara subdivision/Bethany Estates Plat for the property located at 5220 Club Road pending Staff's final review for compliance to all applicable codes, comments and conditions of approval.

Notification letter to the Department of Economic Opportunity re: Evaluation and Appraisal of the Town of Haverhill Comprehensive Plan

The Town Administrator offered Staff's report.
