# FIRST READINGS AND REGULAR AGENDA

#### Consider Plat approval for Haverhill Pointe

Mayor Foy recused himself from discussion and voting on the matter before the Council due to a possible conflict of interest resulting from a prior business arrangement with his firm and the applicant.

Town Planner Josh Nichols and Town Engineer Todd McLeod presented Staff's report. He explained that open space tracts 1-7 were reserved to Haverhill Baptist Church for future dedication to those property owners.

A motion was then made by Vice Mayor Gordon and seconded by Council Member Plyler and passed 3 – to approve the Haverhill Pointe and to authorize the Mayor to sign the Plat on behalf of the Town of Haverhill in his administrative capacity. The vote passed 3-1, with Mayor Foy abstaining from the vote.

Consider application for minor subdivision as filed by Carlos Gonzalez, agent for Gustavo Solana (Cheryl Road – PCN 22-42-43-26-00-0005330)

Josh Nichols presented staff's report. He explained that the request for a minor subdivision and approval of a Preliminary Plan within the Town of Haverhill municipal boundaries to create a total of three parcels mirrors the existing lots on the west side of Cheryl Road.

The applicant Carlos Gonzalez and the property owner Gustavo Solana were present. They represented that the Department of Health had already been contacted. A brief discussion followed.

Town Planner Nichols explained that the Town Code requires that any subdivision of land within the Town into two or more lots shall be done by Plat.

The applicant and property owner expressed objection to having to file a Plat. It was confirmed by Staff that the property across the street had been platted.

Reviewing the two options for recommendation before Council, a motion was made by Vice Mayor Gordon, seconded by Council Member Plyler and unanimously passed (4-0) approve the preliminary subdivision plan to subdivide the subject property onto three parcels in accordance with Section 54-4 and Sections 58-166 – 170 subject to the condition that the final plat must contain the information as required by Section 54-4 (c)(2), F.S. 177, and any items relative to the approval of the Preliminary Plan by the Town Council and any conditions relating thereto, including comments by the Town Engineer.

#### REPORTS

### **Town Attorney**

Attorney Foster reported the Town had received a request for reasonable accommodation from Attorney Lynne pertaining to the sober house located at 791 Haverhill Road.

He reported that the theme for this year's South Florida Fair would be "Discover the Palm Beaches". They would be offering all Palm Beach municipalities a free space at the fair to highlight and showcase their Town. Further information would be forthcoming.

#### Mayor

Mayor Foy reported that he had visited Council Member Beavers at Hospice on the day he passed. The Mayor was confident that although Council Member Beavers was not awake during the visit, he was at peace.

He next reported on the Palm Beach County League of Cities District 2 and 3 luncheon.

The Loxahatchee River Plan has been placed on hold due to lack of funding.

Regarding the FEMA FIRMs, there had been a meeting with Palm Beach County and the municipalities to discuss the acquisition of LIDAR data and specific products that could be obtained at the same time.

#### Town Administrator

The Town Administrator reported that Council Member Beavers' wife, Peggy had requested hosting a "Celebration of Life" at the Town Hall. Council supported the idea.

She next reported on the success of the Halloween event held on October 30, 2015.

A brief discussion took place regarding the upcoming election and whether an appointment would need to be made prior to the March 15, 2016 election.

The motion passed 3-1, with Mayor Foy voting against.
