# COMMENTS FROM THE PALM BEACH COUNTY SHERIFF'S DEPARTMENT

Deputy Kayla Schnell, District 1 Crime Prevention Unit introduced herself to the Town Council. She reported on crime statistics for the previous two week period. There had been a self-initiated graffiti report from the graffiti team; a report of a stolen gun turned out to be a report of a lost gun as the gun was recovered by the rightful owner; there had been a report of shots fired in the Lake Belvedere Estates neighborhood and a report of a stolen dirt bile from 791 Haverhill Road that had been left outside in the open. There had also been 42 traffic stops in the past two week period. All agreed that he permit detail has worked in the favor of the Town. Council expressed their appreciation to Deputy Schnell and the PBSO for continuing to work with the Town of Haverhill.

The title was read by Attorney Fuchs. Mayor Foy opened the Public Hearing. There being no public comment, a motion was made by Vice Mayor Gordon, seconded by Council Member Uptegraph and unanimously passed (4-0) to pass Ordinance 476 on second reading.

#### FIRST READINGS AND REGULAR AGENDA

ACT ON REQUEST OF ROBERT VAUGHN, PROPERTY OWNER AT 757 IVORY LANE, FOR COUNCIL CONSIDERATION OF A CODE ENFORCEMENT LIEN REDUCTION

Director of Public Services, Joseph Roche presented Staff's report. He explained that Mr. Vaughn had been living in the home he constructed on Ivory lane without a Certificate of Occupancy and had installed a shed without a permit. A lien in the amount of \$250 per day had been assessed on the property and had accrued for 154 days before the property was brought into compliance.

Mr. Vaughn, proprietor of Blue Eyes 3 LLC, owner of the property addressed the Town Council. He explained that he had been going through a very difficult time personally and was unable to deal with meeting the demands of the Town. He apologized for his oversight.

Staff reported that the property was now in compliance. Mr. Vaughn had obtained the permit for the shed and paid 4 times the permit fee and had since obtained his Certificate of Occupancy and had paid for his Solid Waste Assessment.

Taking Staff's recommendation and Mr. Vaughn's hardships into consideration, a motion was made by Vice Mayor Gordon, seconded by Council member Sohn and unanimously passed (4-0) to reduce the lien to the amount of \$1,500, which would cover the actual costs incurred by the Town with the proviso that the lien be paid in full within 30 days or the lien would revert back to the full amount of \$40,000.

Mr. Vaughn raised no objection to the time limit imposed.

ACT ON REQUEST FOR VARIATION FROM SECTION 58-319 (H) TO ALLOW FOR A SIX FOOT SIDE YARD FENCE IN THE FRONT YARD SETBACK FOR THE PROPERTY LOCATED AT 4915 CLUB ROAD AS PETITIONED FOR BY THE PROPERTY OWNER MATHURIN BARTHELEMY.

The property owner was present to address any questions raised by the Town Council. **Director of Public Services, Joseph Roche, presented Staff's report**. He explained that the 6' fence would serve as a deterrent to trespassers who currently cut through the property at 4915 Club Road from Orleans Court. The homeowners wanted the additional level of safety for their family. It was his recommendation that the Town Council approve the request for variation.

A motion was made by Vice Mayor Gordon, seconded by Council Member Uptegraph and unanimously passed (4-0) to approve the request for variance to allow for a six-foot fence to be installed on the east side yard lot line at 4915 Club Road.

A motion was made by Vice Mayor Gordon, seconded by Council member Uptegraph and unanimously passed (4-0) to approve that annual contract between the Town of Haverhill and AECOM to perform NPDES monitoring and reporting services in an amount not to exceed \$9,000.
