Those present were Jay Foy, Mayor, Lawrence Gordon, Vice Mayor; Dennis Withington (via teleconference) Council Member; Ray Caranci, Council Member and Theresa Johnson, Council Member. Also, present were John Foster, Town Attorney, and Janice C. Rutan, Town Administrator.

#### CALL TO ORDER

Mayor Foy called the meeting to order at 6:30 p.m.

#### INVOCATION AND PLEDGE OF ALLEGIANCE

Mayor Foy offered the invocation and led the Pledge of Allegiance.

#### **ROLL CALL**

The Town Administrator called the roll. All Town Council Members were present except for Council Member Withington who attended via teleconference.

#### **COMMENTS FROM THE PUBLIC**

#### APPROVAL OF AGENDA

A motion was made by Vice Mayor Gordon, seconded by Council Member Johnson and unanimously passed (5-0) to approve the agenda as presented.

A motion was made by Council Member Johnson, seconded by Council Member Withington and unanimously passed (5-0) to approve the consent agenda.

## COMMENTS FROM THE PALM BEACH COUNTY SHERIFF'S OFFICE

Kayla Schnell, Community Services Liaison for the PBSO was present representing Palm Beach County Sheriff's office. She reported there had been no reports of property crime in the Town for the previous two-week period. She reminded all to lock their cars and keep valuables out of site so not to become a victim of a crime of opportunity.

Council expressed their appreciation to D/S Schnell and the PBSO.

#### **REGULAR AGENDAS**

Act on request of Servando Maldonado, of Servando Maldonado Landscaping LLC, property owner of 5100 Belvedere Road, Haverhill, FL to allow for a variation of Section 58-319 (b) by installing one 5' lion statute on top of each (2) 4' high foundations.

Mr. and Mrs. Maldonado were present to address the Town Council. They explained that they had poured two 4'pillars inside the gate to their driveway and were requesting permission to place a 4' lion statute atop each pillar. Staff asked them to come before Council because the height exceeded the maximum allowed by the Town's Ordinances.

Discussion followed. The pillars were not part of the fencing/gate and were more decorative that structural and the structural part of the project (pillars) had been permitted.

When asked by the Council how they intended to secure the statute to the pillar, they explained they would be reinforcing the placement with rebar.

By consensus, the Council agreed that a variance would not be necessary however, they did wasn't the building official to review their plans to be sure any building requirement would be met.

The Attorney explained that he would add language to the proposed Ordinance that any lot existing prior to the adoption of Ordinance No. 501 would be considered a legal on conforming lot.

It was agreed to workshop the matter on December 7, 2021 and then move the otem to second reading in December.

Edward Stalf, 5263 Belvedere Road. Mr. Stalf addressed the Town Council. He asked how this Ordinance would affect his property and Trailaway Lane. Council explained that this Ordinance was being adopted to regulate individual subdivisions requiring them to construct a road right of way for access to prevent the creation of "flag lots" throughout the Town., They also added that to date Mr. Stalf property had only been before Council as a Planned Unit Development and not an individual subdivision.

Discussion followed with Mr Stalf asking about the creation of the Airport Overlay District and who decided the area to be included in that district. Attorney Foster explained that the area chosen was directly under the flight path of the Palm Beach International Airport, uses being limited by the FAA. Discussion followed.

Mayor Foy reported that he asked this item to be placed on the agenda for discussion purposes only. He was unaware that the units being proposed would have up to 4 bedrooms and as such he

was suggesting the number of required spaces per unit be tied to the number of bedrooms. He added an alternative would be to allow the streets to become private so that there could be perpendicular parking.

Discussion followed and it was agreed the matter would be further discussed at the December workshop.

# COMMENTS FROM THE PALM BEACH COUNTY FIRE RESCUE

Palm Beach County Fire Rescue Battalion Chief Tracy Adams addressed the Town Council. There had been 21 calls for service of which 15 were for medical and 4 for motor vehicle accidents. The average travel time was 6 minutes and 37 seconds. She explained the average turn out time from dispatcher to the truck rolling was 90 seconds.

She proudly announced the 90 recruits had recently graduated.

Discussion followed. She was unable to determine how many of their employees had been vaccinated against the Corona Virus.

The two stations responding to Haverhill calls were Station 23 (Okeechobee and Haverhill) and Station 24 (Westgate)

She reminded all that hurricane season would end on November 30th. .

SECOND READING: ORDINANCE NO. 505: AN ORDINANCE OF THE TOWN THE TOWN OF HAVERHILL, FLORIDA, ADOPTED COUNCIL OF ACCORDANCE WITH SECTIONS 101.161 AND 166.031, FLORIDA STATUTES, CALLING FOR A REFERENDUM TO BE HELD ON MARCH 8, 2022, PROPOSING TO THE ELECTORATE OF THE TOWN THAT THE TOWN CHARTER BE AMENDED AT SECTION 2.03 BY AMENDING THE CHARTER TO PROVIDE THAT IF THE ELECTORS OF THE TOWN APPROVE THE EXTENSION OF THE TERM OF OFFICE FOR A COUNCILMEMBER FROM TWO YEARS TO THREE YEARS, THAT A SPECIAL ELECTION BE HELD FOR ANY VACANCY THAT OCCURS WITH EIGHTEEN MONTHS OR MORE LEFT IN THE TERM OF THE SEAT THAT IS BEING VACATED AND IF NO ONE QUALIFIES FOR THE SPECIAL ELECTION, THAT THE SEAT BE FILLED BY APPOINTMENT OF THE REMAINING MEMBERS OF THE TOWN COUNCIL; PROVIDING THAT IF A VACANCY OCCURS IN A COUNCIL SEAT WITH LESS THAN EIGHTEEN MONTHS REMAINING IN A TERM, BUT MORE THAN ONE HUNDRED SEVENTY NINE DAYS, THE REMAINING COUNCIL MEMBERS MUST MAKE A GOOD FAITH EFFORT TO APPOINT A SUCCESSOR TO FILL THE REMAINDER OF THE TERM; AND IF LESS THAN ONE HUNDRED AND EIGHTY DAYS REMAIN IN THE TERM OF A SEAT BEING VACATED, THE REMAINING MEMBERS MAY, BUT ARE NOT REQUIRED APPOINT A SUCCESSOR; PROVIDING THAT THE REMAINDER OF THE CHARTER, AS MAY BE AMENDED BY THE ELECTORATE, SHALL REMAIN IN FULL FORCE AND EFFECT; PROVIDING FOR THE SUBMISSION OF THE PROPOSED BALLOT QUESTION TO THE ELECTORS OF THE TOWN; SETTING FORTH THE FORM OF THE QUESTION TO BE VOTED UPON AT SUCH ELECTION; PROVIDING AN EFFECTIVE DATE FOR THE AMENDMENTS SHOULD THE AMENDMENTS BE APPROVED BY THE ELECTORS AT THE MARCH 8, 2022, REFERENDUM; PROVIDING A CONFLICTS CLAUSE, SEVERABILITY CLAUSE, AUTHORITY TO CODIFY, AND FOR OTHER PURPOSES The title was read by Attorney Foster. There being no public comment, a motion was made by Vice Mayor Gordon, seconded by Council Member Caranci and unanimously passed (5-0) to approve Ordinance No. 505 on second reading.

Mayor Foy addressed the Town Council. He commented that of all the Ordinances being adopted to amend the Town's Charter, he felt that Ordinance 498 was the most important as it addressed the day-to-day operations of the Town.

SECOND READING: ORDINANCE NO. 508: AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF HAVERHILL, FLORIDA, AMENDING CHAPTER 2, ADMINISTRATION, OF THE TOWN'S CODE OF ORDINANCES,

BY AMENDING ARTICLE III, FINANCIAL MATTERS, DIVISION 2, PURCHASING, SECTION 2-66, BIDDING PROCEDURES, BY DELETING THE CURRENT REQUIREMENTS REGARDING PURCHASING AND IN ITS PLACE AND STEAD ALLOWING FOR THE TOWN TO PURCHASE PERSONAL PROPERTY, COMMODITIES, GOODS AND SERVICES MOTOR UTILIZING **FOR** LESS **THAN** \$65,000 WITHOUT VEHICLES COMPETITIVE BIDDING PROCESS; BUT REQUIRING ALL OTHER PURCHASES IN EXCESS OF \$65,000 TO BE COMPETITIVELY BID, EXCEPT THAT A COMPETITIVE BID SHALL NOT BE REQUIRED IN A TOWN **NOT** TO BY LAW ALLOWED EMERGENCY, **PURCHASES** COMPETITIVELY BID, AND COOPERATIVE OR PIGGYBACK PURCHASES UTILIZING CONTRACTS OF A PUBLIC ENTITY OR NON-PROFIT ORGANIZATIONS; AND AUTHORIZING THE TOWN ADMINISTRATOR TO REGULATIONS FOR IMPLEMENTING AND RULES PURCHASING POLICY FOR THE TOWN OF HAVERHILL; PROVIDING FOR CODIFICATION; PROVIDING FOR SEVERABILITY; PROVIDING FOR THE REPEAL OF LAWS IN CONFLICT; PROVIDING FOR CORRECTION OF SCRIVENERS' ERRORS AND PROVIDING FOR AN EFFECTIVE DATE.

The title was read by Attorney Foster. Attorney Forster offered Staff's report. There being no public comment, a motion was made by Council Member Johnson, seconded by Council Member Caranci and unanimously passed (5-0) to approve Ordinance No. 508 on second reading.

Vice Mayor Gordon reported on the Palm Beach County Days scheduled for January in Tallahassee. He would be unable to attend as planned but would be attending the February statewide Tallahassee Days.

He would be sworn in at the President to the Palm Beach County League of Cities in May. They are planning on holding an in-person event at the Kravitz Center.

### **UNFINISHED BUSINESS**

A brief discussion took place regarding the ARPA funding and projects. The Town Administrator noted that there had been no expenditures from the Infrastructure funds either. She suggested the Woodland Drainage project recently completed could perhaps be assigned to the Infrastructure account. A meeting of the Committee would be scheduled.

The Town Council would want to look at the transition from septic to sewer.

On October 19, 2021 a WastePro truck had taken down utility wires. The Town Administrator and Council Member Caranci reported that repair of the wires by the Utility Companies (FP&L, AT& T and Comcast) were still ongoing. There was a lack of communication between the entities and calls were left unanswered, etc.

Council Member Caranci gave a history on the age of the wires and poles and was adamant that they needed to be upgraded and power/cable/internet restored to those affected.

Vice Mayor Gordon offered to reach out to our legislators for assistance in getting this matter resolved. Mayor Foy suggested Staff contact Commissioner Weiss's office as well.

### **NEW BUSINESS**

Staff had received a proposal for digital services from Shauna Smith of Digital Content Loft. The proposal for social media such as Facebook, web design and Instagram would be presented at the December workshop.

Discussion followed. Concerns over public records law were raised.
